



RECRUITMENT OF MERITORIOUS SPORTS PERSONS IN INCOME TAX DEPARTMENT, KARNATAKA & GOA

LAST DATE FOR APPLYING : 04.01.2013 by 5.00 pm

The Chief Commissioner of Income Tax (CCA), Bangalore region invites applications for the recruitment of Meritorious Sports persons in different Games / Sports as listed below for the post of **INSPECTOR OF INCOME TAX** in the pay scale of **Rs. 9300-34800 + Grade Pay of Rs. 4600/-** and **TAX ASSISTANT** in the pay scale of **Rs. 5200-20200 + Grade Pay of Rs. 2400/-**. The posts are purely temporary but likely to be made permanent. The probation period is for 2 years.

ELIGIBILITY CONDITIONS

1. AGE LIMIT :

For both Inspector of Income tax and Tax Assistant : 18 to 27 years of age as on 30.06.2012.

Relaxation of age : (as per Govt. of India instruction for meritorious Sports persons)

05 years for General/OBC candidates

10 years for SC/ST candidates

The age limit is also relaxable up to 40 years for Departmental candidates (Relaxable upto 45 years in the case of SC/ST)

2. ESSENTIAL EDUCATIONAL QUALIFICATION :

(1) **Inspector of Income tax** : Degree from the recognized University or equivalent

(2) **Tax Assistant** : (i) Degree from the recognized University or equivalent and (ii) Having Data Entry Speed of 8000 key Depressions per hour

3. NUMBER OF VACANCIES :

(1) **Inspector of Income tax** : 03 vacancies

(2) **Tax Assistant** : 19 vacancies

4. SPORTS ELIGIBILITY : Appointments can be made of a sportsman considered meritorious in any of the games / sports mentioned in para 6 with reference to the following criteria:

Sportsman who have represented:

- A State or the Country in a National or International Competition in any of the games / sports as mentioned in para 6
- Their University in the Inter-University Tournaments conducted by the Inter-University Sports Board in any of the games / sports as mentioned in Para 6
- The state Schools Team in National sports / Games for schools conducted by All India School Games Federation in any of the games / sports mentioned in Para 6
- Sportsperson who have been awarded National Awards in Physical Efficiency under National Physical Efficiency Drive

Note: The merit of sportspersons, who fulfill the aforesaid eligibility conditions, shall be considered / decided in the order of preference given above

5. SELECTION OF THE CANDIDATES: -

The applications will be scrutinized and suitable candidates will be short listed for further selection procedure. The short listed candidates are required to appear for **Ground / Proficiency Test, written test, interview and for Tax Assistant post - Data Entry Speed test**

Qualifying the above tests will confer no right to appointment unless Department is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respects for appointment to the post. Recruitment to the post will be made purely on the basis of merit.

6. LIST OF GAMES / SPORTS : (i) Athletics (ii) Chess (women) (iii) Swimming (iv) Tennis (v) Badminton (vi) Table Tennis (vii) Carrom (viii) Football.

Note : In case suitable candidates are not available in any of the games / sports, the Department will not consider recruitment in that game / sports.

7. HOW TO APPLY : Willing & eligible candidates can submit their application as per prescribed proforma to **The Dy. Commissioner (Hq) (Admn), O/o the Chief Commissioner of Income tax, Bangalore-I, C.R. Buildings, No.1, Queens Road, Bangalore - 560001 by post / by hand so as to reach this Office on or before 04.01.2013 by 5.00 PM.**

9. Short listed candidates will be informed by post / email / official website regarding the information for Ground / Proficiency Test, written Test, interview. All short listed candidates will have to make their own arrangements for stay in Bangalore. However, it is clarified that only SC/ST candidates will be entitled to Traveling Allowance as per rules in connection with Ground / proficiency Test, written test, interview to be held.

10. The candidate on appointment will be liable for posting at any place in the Karnataka & Goa Region and he / she shall not apply for inter-charge transfer before rendering regular service of at least 10 years in this Region. A declaration to this effect in the prescribed proforma should be submitted by the applicant along with the application.

11. **Attested Copies** of all the documents in support of claim regarding Date of Birth, Educational Qualification (Marks Sheets & Certificates), Sports Eligibility Certificates, Caste Certificates etc. duly certified by a Gazetted Officer should invariably accompany the application. Further, colour passport size photograph duly attested by the Gazetted Officer shall also be pasted on the application form in the space provided for the purpose.

12. Application received after the due date will not be entertained under any circumstances. Incomplete unsigned applications / applications without supporting documentary evidence / applications of ineligible candidates will be rejected without any further correspondence with the applicants.

13. The candidate must be in possession of the requisite academic qualification for the concerned post as on **30.06.2012**.

14. Sports achievements certified by the authorities other than the recognized authorities (as enclosed to the application prescribed) shall not be considered. The list of recognized National Sports Federations is also enclosed with application for reference.
