

# HIGH COURT OF JAMMU & KASHMIR AT JAMMU

## NOTIFICATION

No. 659 Date: 28.12.2012

1. Applications in the prescribed format (Annexure-A) are invited from the permanent residents of the state of Jammu and Kashmir, fulfilling the eligibility criteria detailed below for the post of Reader (direct quota) in the High Court of J&K in the pay scale of Rs. 9300-34800 + grade pay Rs. 4800/-.

2. **Number and break-up of posts category-wise:**

The total number of posts and reservation for the candidates belonging to the Scheduled Castes, Residents of Backward Area and Scheduled Tribes, shall be as under:

**Note:** The number of posts may increase or decrease depending upon the number of vacancies at the time of final selection;

3. **Eligibility:**


In order to be eligible for appointment to the post of Reader (direct quota), the incumbent:-

- must possess a degree in Law (Professional) from a recognized University established by Law in India and recognized as such by the Bar Council of India;
- the candidates must be of the age as prescribed by the Government for recruitment to the State Government service.

4. **Selection Procedure:**

Selection of the candidates shall be made on the basis of cumulative marks obtained both in the written test and viva voce test.

The application duly filled up by the candidate in his own hand accompanied by two duly attested recent passport size photographs (one of the photograph be affixed at the space in the format) attested copies of the academic/professional qualification certificates, character certificate from the head of the institution last attended, state subject certificate and demand draft of Rs. 300/- in the name of Registrar General High Court of Jammu and Kashmir drawn on any branch of Jammu & Kashmir bank and payable at Jammu, may be personally delivered by the candidate (s) from Jammu Division in the office of Registrar Judicial at High Court Jammu and from Kashmir Division in the office of Registrar Judicial at High Court Srinagar and from Leh and Kargil Districts in the office of Pr. District and Sessions Judge Leh, during schedule office hours on or before **30<sup>th</sup> January, 2013.**



Candidates belonging to any reserved category must indicate the particular category in the relevant column of the application and annex an attested copy of the certificate issued by the competent authority in this behalf.

**Note:**

- a) The selection shall be made as per the reservation rules.
- b) Any wrong or incorrect information furnished by the candidate shall lead to the rejection of his/her candidature at any stage.
- c) Each candidate shall be given receipt number at the time receipt of application itself. All further correspondence with the candidate shall be made quoting the said receipt number allotted to him/her.
- d) The candidates shall have to appear in test as prescribed by the Selection Committee on the date(s) notified separately.
- e) The date of test shall be notified through print media and separate call letters will not be mailed to the candidate(s).
- f) No TA/DA shall be paid for the test/interview.
- g) In-service candidate(s) must route their applications through proper channel.
- h) Incomplete application(s)/applications received after 30<sup>th</sup> January, 2013 or received by any mode other than specified above, shall not be entertained.
- i) The candidate shall have to present his/her Voter Identity/Identity Card at the time of submitting the application.
- j) Canvassing, in any form, shall disqualify a candidate.
- k) The information regarding collection of Roll Numbers etc. will be published in the daily newspapers in due course.
