1.	Minimum Educational Qualification	: (i) Candidate must be a graduate from any university established by Law Ir India or its equivalent examination from any university recognized by the Government for the purpose and (ii) Must have passed-
		"O" level certificate course conducted by DOEACC under control of the Department of electronics;
		Computer Operator & Programming Assistant (COPA)/Data Preparation & Preparation & Computer Software (DPCS) certificate organized under National State council of Vocational Training Scheme;  Or
		Diploma in Computer Science/ Computer Application from any university established by Law in India or from an institution recognized by the Government;
		Diploma in computer Science & Engineering from a Polytechnic Institution recognized by the Government.
2.	Nationality	: A candidate for appointment to the service must be a citizen of India

Age	A candidate for direct recruitment to the service must have attained the age of 18 years and must not have attained the age of 35 years, on the first day of January preceding the last date fixed for submission of the application;  PROVIDED That: (1) the upper age limit shall be relaxed by five years in the case of the member of the Scheduled Caste or Scheduled Tribe or Other Backward Class or Women Candidates;  (2) there shall be no restriction as to age for candidates already serving in connection with the affairs of the State in a substantive or in a temporary
		capacity, having been so appointed prior to his/ her attaining the age of 33 years;  PROVIDED That: the temporary appointment is permissible under the relevant Rules applicable to service to which the person belongs and is made in accordance with those Rules. 7.	Disqualification for appointment	: Birth of a child after 05.07.2006 shall be disqualification for appointment, if thereby the number of surviving children becomes more than two.  Provided that birth of more than one child in single subsequent delivery to a person having single child shall not be a disqualification.

The calculation of speed in Short-hand & transcription on Computer shall be calculated as laid down in the Rajasthan High Court Staff Service Rules, 2002(As amended by order no. Estt./ HC/2012/196/Dt. 07/07/2012).

Candidate shall apply online by filling up the application form available at official website of Rajasthan High Court (www.hcraj.nic.in) from 11.01.2013 to 31.01.2013. No other means/mode of application shall be accepted.

Instructions for filling up the online application form are available on the web-portal. Candidate shall submit the application form online as well as he/ she shall take the print-out of the form so submitted and shall send the same along with the Demand Draft of the fees applicable to him in favour of "Registrar General, Rajasthan High Court, Jodhpur" payable at Jodhpur by registered/speed post or by hand, to the office of Registrar Examination, Rajasthan High Court, Jodhpur, failing which his/ her application shall not be entertained and deemed to be rejected and no claim in this regard shall be entertained. No other document except Demand Draft shall be attached to the printout of the application form so sent

Candidates shall have to produce all the relevant Certificate/documents, on which he/she lays his/her claim for the post, whenever asked for by this office failing which his/her candidature shall be liable to be rejected at any later stage.
