## POST: TECHNICAL SUPPORT HAND (TSH)

PAYSCALE: Basic Pay ₹ 4,900–9,200/- + Grade Pay ₹ 1,700/- + other admissible allowance.

NO. OF POSTS: 102 [General-33, General(EC)-16, SC-14, SC(EC)-7, ST-3, ST(EC)-2, OBC(A)-6, OBC(A)(EC)-3,OBC(B)-4, OBC(B)(EC)-2, Meritorious Sportsperson-2, Ex-Serviceman-10{General-5, SC-2, ST-1, OBC(A)-1, OBC(B)-1].

**OTHER FACILITIES:** Other than Basic Pay & Grade Pay there are Dearness Allowance (DA), House Rent Allowance (HRA), Medical Allowance, Electricity Allowance, Hill Compensatory Allowance, Project Allowance (according to place of posting) LTC / HTC allowance as per the rules of the Company.

**GROSS SALARY:** ₹ 13,200/- (approx).

ELIGIBILITY CRITERIA: Madhyamik or equivalent pass from a recognized Board / Institution with sound Physique, ability to read & write in Bengali / Nepali and elementary knowledge in English.

Minimum 18 years and maximum 27 years as on 01.01.2013. Age relaxation for SC/ST and OBC candidates will be 5 years and 3 years respectively. Ex-Serviceman candidate will get age relaxation according to rules.

**RESERVATION:** Reservation shall be made for SC / ST / OBC(A) / OBC(B) / Exempted Category / Meritorious Sportsperson / Ex-Serviceman candidates as per the guidelines issued by Govt. of West Bengal. SC / ST / OBC candidates from the states other than West Bengal have to apply as General Candidate.

**RESERVATION OF SPORTSPERSON:** Recruitment of Sportspersons against reserved vacancy shall be made only to following sports events -

- 1) Football
- 2) Cricket
- 3) Athletic
- 4) Badminton
- 5) Table Tennis

In order to be eligible, the candidate must produce requisite certificates issued by the respective Competent Authorities in the format as applicable in terms of **Govt. of West Bengal Notifications** and as shown below:

AREA	COMPETENT AUTHORITY
International Competition	Secretary of the National Federation / National Association of the Sports concerned.
National Competition	Secretary of the State Association of the Sports concerned.
Inter-University Tournament	Dean / Director of Sports or other officer in overall charge of Sports of the University concerned.
National Sports / Games for School Education	Director or Deputy Director in overall charge of Sports / Games for Schools in the Directorate of School Education, West Bengal.

The following categories of meritorious Sportspersons shall be given preference in recruitment –

- a) Those that have represented West Bengal or India in a National or International Competition in sports discipline mentioned above.
- b) Those that have represented a University in an Inter-University Tournament conducted by Inter-University Sports Board in any Sports discipline mentioned above.
- c) Those that have represented State School Teams in National Competition for Schools conducted by all India School Games Federation in any spots discipline mentioned above.

**OTHER CONDITIONS:** The candidates will be appointed after being found medically fit. Selected Candidates will be appointed in the regular pay band, initially on probation for a period of one year. The post is transferable anywhere in West Bengal. The selected candidates are required to furnish a Bond of ₹ 50,000/- at the time of joining in the Company and are required to serve the Company for a minimum period of 4 years from the date of joining.

**APPLICATION FEES:** ₹ 150/- shall be deposited as application fees. **SC/ST candidates of West Bengal need not to deposit any fee**. Fee should be deposited in any branch of UNITED BANK OF INDIA in West Bengal through a triplicate Challan. Challan can be downloaded from the website of the Company and have to take a printout of the same in A4 size paper and will have to be deposited in any Branch of UNITED BANK OF INDIA alongwith deposition fee. After depositing fee, bank will provide **Transaction ID** & **SOL ID** which are required to write at the proper place in the Application Form by the candidate. **Application fee will have to be deposited from 26.02.13 to 19.03.13**. Bank will charge ₹ 22/- additionally as Bank Service Charge.

**MODE OF SELECTION:** The candidates will be called for Physical Fitness Test according to deposition of correctly filled-up applications. Candidates who will qualify in Physical Fitness Test will be called for Written Test and shortlisted successful candidates will be called for Interview for selection.
