SELECTION PROCESS

The selection will be on the basis of Personal Interview.

However, the Management reserve the right to raise the minimum eligibility standards/criteria and/or to conduct a screening test, to restrict the number of candidates to be called for Personal Interview, if so required.

Screening test, if conducted, shall be objective type of one hour duration for elimination purpose only and shall not carry any weightage in final merit. Other details shall be intimated separately, if required.

Offer of engagement shall be sent to candidates found suitable in interview in the order of merit and depending upon the number of vacancies. The final engagement of candidates is subject to their medical fitness as per company's standards and other joining formalities. No relaxation in health standards is allowed.

Important Terms and Conditions of engagement

The engagement is **purely temporary in nature and on contract basis for a period of two years or completion of project whichever is earlier**. Contractual engagement will automatically come to an end on the expiry of aforesaid period of two years or completion of project whichever is earlier and persons will have no right or claim to continue with POWERGRID beyond the specified terms or seek regular employment.

Contract personnel will be paid consolidated monthly remuneration as under:

Contractual personnel will be entitled for Leave, medical benefits etc. as per their detailed terms & conditions of engagement (to be issued to candidates alongwith offer of engagement if selected). Further, contractual engagement will be regulated by Company's rule and administrative orders that may be in force from time to time during the period of engagement.

2. **Wherever, posts are not reserved for PwD but are identified suitable for PwD as per Govt. Notification, they can also apply subject to meeting eligibility requirement.**
3. For SC/ST/PwD candidates : Reimbursement of Second Class rail/bus fare by the shortest route for to and fro travel for the purpose of appearing in test, on production of railway ticket/number/bus ticket for onward journey and self attested copy of SC/ST/PwD certificate, is admissible, restricted to distance between the address for communication and the test centre.

GENERAL CONDITIONS

1. The requirement is purely temporary and on contract basis for a period of two years or till completion of project, whichever is earlier. The post is not against any permanent vacancy and this contractual engagement will not confer any lien and/or right, whatsoever, for regularization of their services in the company.
2. Only Indian Nationals are eligible to apply.
3. Vacancy may vary depending on requirements.
4. Minimum age limit is **18 Years** as on **20.06.2013**.
5. Candidates working in Govt./ Semi Govt./ PSE should apply through proper channel or produce NOC at the time of Interview.
6. Candidates claiming reservation/ relaxation/ concession should submit an attested copy of certificate in proof of Caste/PwD/Ex-Servicemen, issued by a Competent Authority in the prescribed GOI format alongwith the application.
7. Categories of PwD eligible for the posts shall be as per the categories of PwD identified suitable for the posts as per Govt. Notification.
8. For the Un Reserved (UR) posts, SC/ST/OBC(NCL) candidates can also apply subject to meeting with all general standards of eligibility.
9. Candidates should use latest colour passport size photograph and should use the same photograph throughout the recruitment process.

10. Last date of receipt of applications shall be the cut off date for calculation of eligibility requirement. Date of issuance of mark sheet shall be taken as the date of acquiring qualification.
11. POWERGRID will not be responsible for any postal delay or loss of application in transit.
12. Mere submission of application does not guarantee the adequacy of candidature for being considered for further selection process.
13. Eligibility of candidates can be checked at any stage during / after the selection process.
