Candidates are advised to write their name and other details on the reverse side of the DD. No application fee need to be paid by the candidates belonging to SC/ST.
4. The application should be accompanied with attested copies of certificates in support of educational qualification, Marks Memorandum, age and experience.
5. Duly completed application should be sent to The General Manager, Currency Note Press, Nasik Road 422 101, Maharashtra, through registered/speed post only so as to reach Currency Note Press, Nasik Road by **19.08.2014**. Application received late/incomplete will be rejected in toto. Currency Note Press Management will not be responsible for any postal delay/loss of documents during transit.
