- **8. Age limit:** The minimum age limit is 18 years for all categories and the maximum age limit is as under:-
 - (a) 40 years in the case of a person belonging to Scheduled Caste or Scheduled Tribe or Category-I of other Backward Classes.
 - (b) 38 years in the case of a person belonging of Category II-A or II-B or Category III-A or III B of other Backward Classes; and
 - (c) 35 years for others.
 - (d) Not withstanding anything contained in Rules 6 of the Karnataka Civil Services (General Recruitment) Rules, 1977,
 - i. in case of an applicant who is working or holding a post under the Government of a local authority or a Corporation established by a State Act or Central Act or established by the Government under a State Act or Central Act and owned or controlled by the Government by the number of years during which he is or was holding such post or ten years whichever is less;
