Before applying candidates must ensure that they possess the above mentioned Physical Standards. Selection of candidates is subject to being found medically fit by the medical officer of the Company as per prescribed rules of the company.

III. SELECTION PROCEDURE

Eligible candidates will be required to appear in Written Examination. On the basis of their performance in the Written Examination they will be called for Interview. Weightage for written test and Interview will be 80:20 respectively (Selection will be subject to candidates being found medically fit by the Medical Officer of the Company as per prescribed rules of the company). Information for Written test and Interview will be provided on our website www.sail.co.in.

IV. TRAINING & PROBATION:

Candidates selected as Attendant-cum-Technician Trainee will be placed on training for a period of 2 Years which may be extended by another two years as per requirement. On successful completion of training period, they shall be regularized as Attendant-cum-Technician in S-1 Grade. After successful completion of Training, Candidates shall be placed under probation for 1 year.

V. EMOLUMENTS AND OTHER BENEFITS

Candidates selected as Attendant-cum-Technician Trainee will be paid consolidated Pay of Rs. 8600/-pm during 1st year of training and Rs. 10000/-pm during the 2nd year of training. During the period of 2 year training Trainees will also get Medical facility for self, spouse and dependent children. Leave etc will be as per the Rules of the Company.

Eligible and interested candidates would be required to apply online through SAIL's website: <u>www.sail.co.in (Career with sail)</u>. <u>No other means/mode of application will be accepted.</u>

Payment through Pay-in –Slip

State Bank of India has been authorized to collect the application and processing fee, in a specially opened account (SBI Power Jyoti A/c No. 31877168126 maintained by at SBI sector 4, B.S.City branch), on behalf of SAIL/Bokaro Steel Plant. Candidate has to approach the nearby SBI branch with a printout of the "SBI Challan" which is available on the Application Registration Portal. The SBI Challan printed from the Portal only should be used for depositing the fee for proper crediting of amount in the allocated account. On receipt of the money, the concerned branch of SBI will issue a unique Journal Number and a Branch Code of the branch collecting the money. This Journal Number and the Branch Code are to be filled up by the candidate during online registration. In case a candidate deposits the fee in a wrong account, or doesn't finally submit the application form with payment details, SAIL/Bokaro Steel Plant will not be responsible. There will not be any other mode of collection of application/ processing fee. Also please note that the candidate will have to bear the Bank charges of certain amount to be paid to the collection branch of SBI in addition to the applicable application/processing fee.
