## RECRUITMENT - MEDICAL OFFICER

Chhattisgarh State Power Holding Co. Ltd. invites application for the post of Medical Officer in C.S. Power Companies :

Vacancies shown are tentative subject to revision before final selection.

The candidate of Indian nationality fulfilling criteria can apply for the post of Medical Officer.

1/ **PAY SCALE** : Rs. 20425-675(3)-22450-900(8)-29650-1250(5)-48400/- + Allowances (Tentative Total emoluments shall be approximate **Rs. 45,662/-**, House rent allowance as applicable will be extra). During the probation period and after regularization they will be get all allowances and other benefit as per company's rules. **Two advance increments will be given to the appointee's with Master Degree and one advance increment will be given to P.G. Diploma holder.**

2/ **QUALIFICATION** : The qualification for the post of Medical Officer is MBBS degree from recognized University and valid registration with Medical Council of India.

3/ **RESERVATION** :

(a) SC/ST/OBC candidates of CG state domicile only will be considered for the reserved post in respective categories as per CG Govt. guidelines, in this regard.

(b) Reservation for woman candidates will be given as per the Govt. of CG guidelines, in this regard.

(c) The post of Medical Officer is not identified cadre for recruitment of persons with disabilities as per circular no. 01-04/PD-III/1119(3)/291 dtd. 21-01-2010 hence no post will be reserve for persons with disabilities.

4/ **AGE LIMIT (As on 31-03-2015)** : Maximum age limit : 30 years for candidates other than CG State domicile and 35 years for CG State domicile. 5 year age relaxation for SC/ST/OBC candidates and 10 years age relaxation for Female candidates will be given as per the Govt. of CG rules in this regard. Including all

relaxation maximum age should not be more than 45 years for all category of candidates.

**5/ SELECTION PROCESS :** The following procedure will be adopted for selection :

- (i) Selection will be based on merit list prepared on the basis of marks obtained in written test and interview put together.
- (ii) The selection will be based on written test of 100 marks followed by interview of 10 marks. The written test paper will consist of 100 objective type multiple choice questions comprising of 80 from clinical and non-clinical subject of MBBS and 20 from the area of General Awareness & Reasoning. Candidates will be called for interview in the ratio of 1:3 from the merit list prepared on the basis of marks obtained in the written test. Final merit list for selection will be prepared on the basis of marks obtained in written test and interview put together.

**6/ APPOINTMENT :** Selected candidates will be appointed as Medical Officer and may be posted in any of the Dispensary/Hospital of C.S.Power Companies. After satisfactory completion of 2 years probation period, they will be regularized. The selected candidates shall be required to execute a bond to serve the Power Companies for a period of minimum Four years. The bond amount will be Rs. 3,00,000.00.

**HOW TO APPLY :**

(i) **LAST DATE OF SUBMISSION :** The application in the prescribed format should reach following Address : "Dy. General Manager(HR)-II, CSPHCL, Dangania, Raipur, Pin.- 492 013" positively on or before **06/04/2015**. The application received by **registered post** or **speed post** will only be accepted. Application by hand/courier/any other means shall not be accepted. Envelop should be clearly super scribed as "**Application for the post of Medical Officer**".

(ii) **APPLICATION FEE :** Rs. 1000/- for General, OBC category & SC/ST category candidates of other than Chhattisgarh State AND Rs. 700/- for SC/ST category candidates of Chhattisgarh State in form of non-refundable **D.D./Banker's Cheque in favour of "Assistant Manager (CAU), CSPHCL, Raipur"** payable at Raipur (Chhattisgarh). The candidates should write their Name and complete mailing address on reverse side of D.D./Banker's Cheque.

(iii) **OTHER CONDITIONS :** The **SC/ST/OBC** candidates of **CG** state are required to submit permanent caste certificate issued by the competent authority of **C.G. Govt.** along with the application. **Otherwise benefit of reservation will not**

be given and the candidature of those applicants will be treated as UR category. Moreover affidavit in the prescribed proforma needs to be submitted by SC/ST category candidates at the time of interview, if called for interview. In case of OBC candidates latest Permanent Caste Certificate or Permanent Caste Certificate with latest Non-Creamy Layer Certificate issued by competent authority alongwith affidavit at the time of interview needs to be submitted, if called for interview. Candidature of other than CG state domicile of SC/ST/OBC category shall be accepted against UR category only (Max. age 30 years) with a valid DD of Rs. 1000/- with the application otherwise it will be rejected. Application received after due date shall not be considered under any circumstances. Incomplete, unsigned application not in prescribed format / without photograph/without requisite D.D./without copy of qualifying examination final year mark sheet/without permanent caste certificate/domicile certificate in case of C.G. State candidates shall be rejected and no further correspondence shall be entertained. Traveling allowance will be paid to SC/ST/OBC candidates as per company rules.
