2. These posts will be filled up on deputation basis from the officers of equivalent grades of Customs, Central Excise and Service Tax usually for a period not exceeding 5 years in the Pay Band PB 2-9300-34800 with Grade Pay Rs.4800 / Rs.5400 for SIOs and Grade pay Rs.4600/Rs.4800 for IOs. As

per the recruitment rules, the willing officer should have put in a minimum of three years of service in the grade. **The officer selected will be entitled to draw special allowance as per existing rules.** Officers who are selected, however will have to make their own arrangements for residential accommodation.
