- 1. The candidate must be a citizen of India belonging to North Eastern Region only.
- 2. The recruitment is exclusively for North Eastern Region only.
- 3. Application Forms can be obtained in the following manner:
  - a) In person from the Deputy Secretary (SR), Coffee Board, No.1, Dr. B.R. Ambedkar Veedhi, Bengaluru 560 001, on submission of a requisition during all working days (Monday to Friday), between 09.30 AM and 6.00 PM.
  - b) By post by submission of a requisition along with a self-addressed envelope (30 x 25 cms size) duly affixing Indian Postal Stamp for `100 (Rupees one hundred only) for each application, from the Deputy Secretary (SR), Coffee Board, No.1, Dr. B.R. Ambedkar Veedhi, Bengaluru 560 001.
  - c) Can be downloaded from the Coffee Board's website www.indiacoffee.org
- 4. Crucial dates for issue / submission of application:

- 5. The candidates should use only the prescribed Application Form obtained in person or by post or downloaded from the Coffee Board's website. Applications submitted by the candidate in any other format will summarily be rejected.
- 6. Before applying, candidates are advised to ensure that they fulfil the stipulated eligibility criteria for the post.
- 7. A recent, recognizable passport size photograph should be firmly pasted at the place indicated in the Application Form Part 'A' and Part 'B' and must be signed across the photograph so that a part of the signature spreads over the application form beyond the photograph.
- 8. The application shall be filled-up in English (Capital Letters) only. Corrections, if any should be legible and attested by the candidate. Candidates shall ensure that the particulars once submitted by them will be final and no further changes will be allowed thereafter.

- 9. The candidates are advised to fill 'Part 'A' and B' of the Application Form carefully and each and every column of application should be filled up accurately. Incomplete applications are liable to be rejected.
- 10.
