As the the District Level Selection Committee, Malda, has[in view of delay occurred to conduct recruitment test to fill up vacant posts in the cadre of Nirman Sahayak (of Gram Panchayat) /Block Informatics Officer (of Panchayat Samiti)/Data Entry Operator(of PS), subsequent to previous publication of recruitment notice vide Employment Notification No. DLSC/ABP/01/13-14 dated 08/01/2014] decided to provide a limited opportunity to those who could not apply earlier for the said posts due various reasons and willing to apply and having requisite qualifications as of now; a limited opportunity for application in prescribed format are hereby invited from Indian Citizen as defined in Part-II of the Constitution of India for recruitment to different posts at Gram Panchayat and Panchayat Samiti level under Malda district.

Those who have applied already before following the above mentioned notice dated 08/01/2014 need not apply as their candidature have already been enrolled. For those who have applied earlier as an unreserved candidate, but have become eligible for reservation for certain category for which vacancy exists, can make necessary correction(Edit) as mentioned in the site following site instructions and submitting due testimonials

Willing candidates yet to apply, having requisite qualification shall be required to apply online in the website <http://www.malda.gov.in> on or before the closing date i.e.06/04/2015 upto 5:00 pm. The relevant particulars like name of the posts, qualification, age limit, scale of pay and anticipated vacancy position under each category of posts are stated in the following paragraphs. A candidate must go through the instruction thoroughly and carefully before submitting online application. Any omission/ suppression of information shall lead to rejection of application or candidature at any stage of the process without further intimation. The conditions so prescribed shall not be relaxed. Selection will be made through an open competitive examination to be conducted by the District Level Selection Committee, Malda. Mode of Application :-

Step-1:- Online Registration :

> All applicants shall apply for any post by submitting their applications in the website <http://www.malda.gov.in> through online submission.

- An application form along with a unique registration number will be generated thereafter automatically.
- This registration number shall be preserved for any future reference and generation of Admit Card etc.
- After filling up and submission of the application form properly, a print out shall be taken for future reference.
- Last date for online submission of the application is 06/04/2015 upto 5:00 pm.
- There shall be no provision for receiving of hard copy of the application form in this office.
- Self-Attested copy in respect of proof of birth, academic qualification, photograph (seal/signature should not impair facial portion of image), and caste – as mentioned in “Particulars to be verified” portion given below.

Grounds of Rejection of Application Form :-

- ✓ The application form received by post shall be rejected straightway.
- ✓ Any application form which is incomplete in nature shall be rejected.
- ✓ Any application form which is not submitted with testimonials in respect of date of birth, academic qualification, photograph, caste(if any) etc.

Step-2 :- Generation of Admit Card :

- ✓ The applicant will have to generate the Admit Card by putting his/her auto generated Registration Number along with his/her date of birth in the respective place. It will be available in the website www.malda.gov.in around June, 2015. Final program will also be informed in the said site.
- ✓ After generation of the Admit Card, a print out is to be taken.
- ✓ Two copies of identical colour passport size photograph self-attested to be affixed on the Admit Card in the place earmarked for the purpose.
- ✓ The lower part of the Admit Card is to be signed by the applicant in examination hall on the day of examination and to be handed over to the invigilator.
- ✓ The candidate shall have to bring with him/her any photo identity document viz. EPIC, PAN Card, Passport, Admit Card / Certificate of Madhyamik or equivalent with photograph/ Driving License/ Bank Pass Book containing photograph of the candidate/ any other photo identity card issued by the competent Govt. Authority.
- ✓ Candidate without Admit Card and any photo identity document as mentioned above shall not be allowed to enter the examination hall.

Mode of Examination :-

Part –I : Written Examination including practical test wherever applicable : (85 marks)

Part –II : Viva Voce Test : (15 marks).

- 1) Candidates will be short-listed for Viva –Voce test from the list prepared in descending order of the marks obtained by the candidates in written examination subject to fulfillment of minimum qualifying marks in written examination (including practical test where applicable) as fixed up by the DLSC.
- 2) The successful candidates in the written examination will be called for appearing in the Viva-Voce test in 1 : 5 ratio against the total number of vacancies in a particular post.
- 3) The successful candidates of the posts for which computer knowledge is essential or desirable, shall have to undergo a Computer Test at the time of Viva-Voce.
- 4) The Written Examination will be through MCQ / Descriptive (where applicable) method and there will be negative marking for wrong Answer (One mark will be deducted for every four wrong answers given).

General Conditions Fixed by the Committee ::

- Willing candidates can apply online with effect from the date of advertisement till the last date i.e, upto 05:00 pm on 06/04/2015.
- Submission of more than one application for a single post is strictly forbidden. The candidature of a candidate, who submits more than one application for a single post for admission to the examination, will be cancelled even he/ she is eligible for the same. If due to inadvertence any wrong information has been made, it should be verified before "confirmation" of application and rectification of information can be made before "confirmation" stage. Candidates applied earlier can EDIT their information with same ID.
- Print out of online submission of application can neither be claimed as a proof of application, nor accepted as a demand to appear in the written test. Only Admit card with other valid testimonials, like photographs and any photo identity card as mentioned below, will be considered at the time of written test.

- Incomplete applications will be summarily rejected.
- Admission to the examination will be purely provisional subject to verification of eligibility at a later stage. Therefore, candidature of any candidate shall be rejected straightway if found not eligible at any stage, even after appearance in the examination.
- Candidates must bring their photo identity card recognized by the Govt. in order to get entrance into the examination venue to prove their identity.
