## 2. EDUCATIONAL QUALIFICATION

The qualification which qualifies the candidate should be from recognized universities/institutes under the full time/regular scheme only.

## 3. EXPERIENCE

Experience will be as per the above mentioned criteria. Only post qualification experience shall be considered.

#### 4. GENERAL CONDITIONS:

- (2) Appointment to the posts will be on regular basis. Candidates appointed on regular basis will be on probation for a period of one year.
- (3) Selected candidates during the period of his/her employment will be required to serve at any other location/office of NTC situated anywhere in India.
