

Advertisement for Vacancies in Naval Armament Inspection Organization in Eastern Naval Command, Visakhapatnam

1. Applications in the prescribed format are invited from eligible persons for the following posts:

Chargeman-II (Mechanical)	Bachelor of Science degree with Physics or Chemistry or Mathematics from a recognized University or institution Or Diploma in Electrical or Mechanical or Electronics or Production Engineering from a recognized University or Board.	18 to 25 years

3. Age Relaxation:

- (a) The upper age limit is relaxed by five years for SC & ST and three years for OBC for the posts reserved for the respective categories.
- (b) The upper age limit is relaxed for Government Servants as under :-
 - (i) For the post of Examiner (Ammunition) and Chargeman-II (Mechanical) - Upto five years
 - (ii) For the post of Draughtsman (Armt) Grade-III - Upto the age of 40 years in the case of General candidates and upto 45 years in the case of SC & ST candidates.
- (c) For Ex-Serviceman length of Military Service increased by three years.
- (d) Any other relaxation as per central government orders in vogue.

4. The above posts carry all India service liability and selected candidates are liable to serve anywhere in India.

5. General Instructions:

- (a) Applications as per the given proforma, with attested copies of certificates in support of age, educational qualifications, technical qualifications, caste, experience etc. should reach to the **"The Controller, Controllerate of Naval Armament Inspection, NAD Post Office, Visakhapatnam, Andhra Pradesh-530009"** by ordinary post only, on or before **31 Oct 12**. The last date of receipt of applications by post from candidates residing in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh Division of Jammu and Kashmir State, Lahaul and Spiti District and Pangi sub-division of Chamba District of Himachal Pradesh, Andaman and Nicobar Islands or Lakshadweep, is **07 Nov 12**.
- (b) The envelope containing the application should be clearly superscripted in Bold letters with the name of the post applied for and reservation category viz SC /ST / OBC/ UR as applicable, for example:- **"Application for Chargeman II Category OBC"**
- (c) The reference date for determining the age limit will be the closing date for the receipt of applications i.e. **31 Oct 12**.
- (d) Ex-serviceman to produce certificate in support of their claim and meet Govt. orders on qualifying as Ex-serviceman.
- (e) Candidates applying for more than one post should send separate applications for each post.
- (f) If any declaration given or information furnished is found to be false or is found to have been willfully suppressed the candidature is liable for outright rejection at any stage.
- (g) Incomplete application, application with insufficient details/ with other than the format prescribed/ without attested photocopies of certificates etc , will be summarily rejected without ascertaining any reason.
- (h) Application received after due date will not be considered.
- (j) OBC candidates to produce an attested certificate in the prescribed form issued by Competent Revenue Authority not below the rank of Tehsildar/Mandal/Revenue Divisional Officer as prescribed vide OM No. 36012/22/93-EStt(SCT) dt. 08-09-93 as amended vide No. 36033/3/2004-Estt (Res) dt. 09-03-2004. SC/ST candidates to produce certificate in support of their claim and attested copy of certificate in the prescribed form issued by the Competent Revenue Authority not below the rank of Tehsildar/Mandal/Revenue Divisional Officer.
- (k) **Original certificates should not be sent. Only attested copies of certificates are to be enclosed with the application.**
- (l) The vacancies shown above are provisional and may vary/ be reduced/ increased or even made NIL without assigning any reason.
- (m) Eligible candidate working in Central Government/State Government etc must submit their applications through proper channel and have to produce 'No objection Certificate' from their present employer at the time of interview.
- (n) The Competent Authority reserves the right to select the criteria for short-listing the candidates to be called for written examination/ interview/ any other test as relevant.
- (p) The department shall not be responsible for any postal delay/loss.
- (q) Canvassing in any form will be a disqualification.
